 - The Borough is a member of the Berks County Uniform Construction Code Board of Appeals, which requires annual approval by Council. There is a \$300 annual membership fee to participate, which covers the Board's operating costs.
 - A motion is needed to table, approve or deny, recommending Council execute the Intergovernmental Agreement with the County of Berks, for participation in 2026 of the Berks County Uniform Construction Code Board of Appeals
6. Explanation of Borough Infrastructure
 - Jim Babb will give an overview of the Borough's water, sewer, storm sewer and streets for newly elected Council Members
 - Discuss other infrastructure topics that the committee would like more information to be provided on at future meetings
7. 4th & Oley Pump Station
 - Revised EDU cost \$2,500 / EDU based on \$175,000 that will be received from Boiler House, Windsor St and RM Palmer.
 - No additional development can occur that flows to either of these pump stations without upgrading one or both of the stations.
 - Van Reed Apartments and Studios on Spring (aka The Inn at Reading) will each be responsible for all of their own upgrades to the Sanitary sewer system including the pump stations that flow to.
 - Anticipate bidding in Fall of 2026 for work to commence in 2027

8. Western Berks Water Authority

- RAWA will own and maintain line and split costs 50/50 with WBWA. WBWA asked the Borough to split their 50% share with the Borough 25/25

9. Sanitary Sewer**A. Wyomissing Borough – West Lawn Interceptor**

- Project Budget is \$1,585,584. The Highlands has contributed \$300,000 and the H2O PA Grant for \$700,000 was awarded the Borough.
- WQM Part II Permit has been obtained.
- Project awarded to JNS Paving and Excavating Corp. in the amount of \$539,238.00.
- Pay Application #2 from JNS Paving and Excavating has been received in the amount of \$44,634.60.
- A motion is needed to approve, table, or deny recommending payment to Council for pay application #2.

B. Wynnewood Pump Station Upgrades

- McCarthy has been authorized to design and permit the upgrades. Council can plan to fund the project after the permits are obtained.
- Expect to have the conceptual design and budget pricing this fall.

10. Streets**A. Penn DOT State Hill Road Improvements (Sewer, MS4, PAWC and WBWA)**

- Phase 1 is from Colony Drive to SR 222 Ramp. Previously PennDOT stated April 10, 2026, contracts let for work. Due to PennDOT redesign we are expecting at least a year delay and project pushing in 2027.
- PennDOT has scheduled a Public Officials meeting for October 20th at 5:00 PM and a Public Input meeting at 6:00 PM, at the Wyomissing Hills Elementary School

B. 50/50 Sidewalk Project

- Project awarded to Forino Co., LP in the amount of \$130,343.50.

C. 2026 Street Work

- Authorization to prepare and advertise bids.

- No further decisions will be made until grant funding is secured to offset the cost of the project

13. Berkshire Heights Playground

- Forester Jacob Schultz will be starting work on the Forestry Plan in the first quarter of 2026
