AN ORDINANCE OF THE BOROUGH OF WYOMISSING, COUNTY OF BERKS, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2021.

This Ordinance concerns a tax to be levied on all real property within the Borough subject to taxation for the fiscal year 2021 as follows: tax rate for general purposes in the sum of 4.50 mills on each dollar of assessed value.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the
